NURE 130 Application Fall 2018

Students enrolled in Union County College as a Trinitas School of Nursing (EGHN) major are required to submit a NURE 130 Application to be considered for enrollment into the Generic RN Track. The NURE 130 application will provide the information that is necessary to determine eligibility for course enrollment.

Acceptance into NURE 130 does not guarantee enrollment in future clinical nursing courses. Please note, students that hold a Practical Nursing License (LPN) are not eligible to register for NURE 130. LPN's may email Associate Dean Santee at santee@ucc.edu for information regarding registration into the LPN -RN Track.

In order to be considered for NURE 130 enrollment, applicants will need to meet the minimum eligibility requirements listed in the table below. This table is designed to help you determine if you are meeting all NURE 130 enrollment requirements.

Explanation of NURE 130 Enrollment Requirements (by number) – Fall 2018

- 1. Completion of the Union County College application and admission process**
 - a. Completion of the Union County College application and admission process is required to be admitted into a Trinitas School of Nursing (NURE) course. For detailed information regarding the Union County College admission process please visit www.ucc.edu/admissions/.

- 2. Completion of developmental course work**
 - a. If applicable, successful completion of MAT 017 and ENG 097 are required to be admitted into a Trinitas School of Nursing (NURE) course.
 - b. This requirement is not applicable to students who have met the passing standard on Union County College placement testing and placed into college level courses.
 - c. Students with questions regarding whether they are required to complete developmental coursework should e-mail an Academic Advisor at nursing@ucc.edu.

- 3. Completion of or current enrollment in NURE 130 co-requisite courses***
 - a. The NURE 130 co-requisite courses are BIO 105, ENG 101 or 112 and CHE 114.
 - b. To be admitted into NURE 130, these courses must be completed at Union County College or accepted by Union County College as transfer courses, and must reflect on the applicant's unofficial Union County College transcript.
 - c. A grade of C or better is required in all Science courses.
 - d. *Co-requisite courses are recommended to be taken before NURE 130, if possible.

- 4. Established GPA of 2.5 or better at Union County College or high school GPA* of 2.5 or better**
 - a. A GPA of 2.5 or better is required** to be admitted into NURE 130.
 - i. The GPA must be established at Union County College *or*
 - ii. *A high school GPA will be considered for applicants who graduated high school within a year of NURE 130 application submission.
 - b. **The only exception to the 2.5 GPA requirement is for students who have transferred all NURE 130 co-requisite courses and have a Union County College GPA of zero (0).
 - i. These NURE 130 applicants will be admitted to NURE 130 if space in the course remains available after all students with a GPA of 2.5 or better have been admitted.

- 5. Attendance at a Trinitas School of Nursing Information Session**
 - a. Attendance at a Trinitas School of Nursing Information Session is required prior to submission of the NURE 130 Application.
 - b. The current Information Session schedule and instructions on how to register can be found on the homepage of www.trinitasschoolofnursing.org.
 - c. Please note, the last Trinitas School of Nursing Information Session for students planning to apply for **Fall 2018 NURE 130 enrollment is Tuesday, May 15, 2018.**

- 6. Completion of the TEAS Assessment**
 - a. All students submitting a NURE 130 Application are required to complete the ATI Test of Essential Academic Skills (TEAS) prior to submission of a NURE 130 Application.
 - b. Students achieving a total score of 50% or higher on their TEAS Assessment are eligible to submit a NURE 130 Application.

- c. All prospective NURE 130 students are responsible for reviewing and understanding the TEAS Assessment information on the following page of the Trinitas School of Nursing website <http://trinitasschoolofnursing.org/TSON-teas.htm>.

Explanation of NURE 130 Admission Decisions – Fall 2018

Registration for NURE 130 is by invitation only. NURE 130 registration invitations are based on:

- The applicant meeting all minimum enrollment requirements to register for NURE 130.
- The number of NURE 130 seats available for the semester.
 - There are a limited number of NURE 130 seats available for qualified applicants each semester.

A note to transfer applicants:

- While transfer credits are accepted, students who have taken nursing curriculum courses at Union County College will have priority ranking for admission into NURE 130. This is based on the Union County College GPA and quality (grade) point calculation used for NURE 130 admission decisions.
- Transfer applicants with two or more failures in a nursing course at another institution will not be considered for NURE 130 admission.
 - A nursing failure is defined as a grade of C or below or a numerical grade less than 75.

A note to NURE 130 re-entry applicants:

- There are a limited number of NURE 130 re-entry seats available each semester.
- The minimum GPA requirement for NURE 130 re-entry is 2.5.
- There is no guarantee of re-entry into NURE 130.

NURE 130 Application Submission Instructions – Fall 2018

NURE 130 applications for the Fall 2018 semester will be accepted from:

- **Monday, May 21st, 2018 through Thursday, May 31st, 2018**
 - Applications will not be accepted before 8:30am on May 21st.
 - Applications will not be accepted after 4:30pm on May 31st.

Required NURE 130 application attachments:

- Unofficial Union County College transcript printed from Owl's Nest
 - The attached unofficial Union County College transcript must be printed from Owl's Nest. Attached transcripts in any other format will not be reviewed.
 - Instructions on how to print an unofficial Union County College transcript from Owl's Nest are available on www.trinitasschoolofnursing.org under Program Info – NURE 130 Application Information.
 - Applicants are advised to print their unofficial Union County College transcript at the time of application submission to ensure all information on the transcript is current.
- TEAS assessment results*
 - NURE 130 applicants who have taken the TEAS at Trinitas School of Nursing must attach a printout of their TEAS results to their NURE 130 application.
 - *If the applicant completed the TEAS at another institution, they must purchase a TEAS transcript and indicate Trinitas School of Nursing as their institution in the request.

- These are the only two methods in which TEAS scores will be accepted. **If the School of Nursing is not in receipt of the applicant's TEAS results by the May 31st, 2018 application deadline they will not be considered for NURE 130 admission.**
- Official high school transcript*
 - *Only applies to applicants who meet the timeframe criteria to be evaluated on a high school GPA.

Methods of NURE 130 application submission:

- In-person during office hours
 - NURE 130 applications may be delivered in-person to the Trinitas School of Nursing Main Office (40 West Jersey St., 3rd Fl., RM 324, Elizabeth, NJ 07202).
 - Office hours are 8:30am to 4:30pm – Monday through Friday
- Locked drop box submission after hours
 - NURE 130 applications may be submitted in the locked drop box located in front of the Trinitas School of Nursing Administrative Suite (40 West Jersey St., 3rd Fl., Elizabeth, NJ 07202).
 - The locked drop box can be accessed only if the Union County College Kellogg Building is open.
 - NURE 130 applications submitted in the drop box before 8:30am on Monday, May 21st, 2018 or after 4:30pm on Thursday, May 31st, 2018 will not be considered.
- By mail
 - NURE 130 applications can be mailed to:

 - NURE 130 applications received by mail before Monday, 21st, 2018 or after Thursday, May 31st, 2018 will not be considered.
 - While not required, it is recommend for mailed NURE 130 applications to be sent using a trackable method (ex: certified mail)

Do not submit a NURE 130 Application unless you meet all minimum NURE 130 enrollment requirements and your current Union County College unofficial transcript reflects your eligibility.

Please note: A criminal background check done through TABB must be completed prior to registration for **NURE 131**. This background check must be **negative or clear** in order to enroll in all NURE clinical courses, beginning with NURE 131. The background check is mandated by all clinical agencies utilized for nursing clinical experiences. **There are no exceptions to this policy.** If you have questions regarding the background check policy, please email trinitas@ucc.edu.

Applicants invited to register for NURE 130 will be notified via their Union County College Owl's Nest e-mail account only. This e-mail will include a registration appointment date and time. **NURE 130 registration invitations will not be sent to a personal email address, nor will an email be sent if you do not include your Union County College Owl's Nest email address on your NURE 130 application.** Incomplete NURE 130 Applications will not be considered and will not be saved.

NURE 130 enrollment and eligibility requirements, as well as registration protocol are subject to change at the discretion of Trinitas School of Nursing.
